The Petition of *Louis Eicke*  
A NATIVE of *Germany*

Respectfully Sheweth,

That he declared on oath before *the Prothonotary of the Courts of Common Pleas for the County of Philadelphia*

on the *Twelfth* day of *November* A. D. *1887* that it was bona fide his intention to become a Citizen of the United States, and of renouncing forever all allegiance and fidelity to any Foreign Prince, Potentate, State or Sovereignty whatever, and particularly to the

*Emperor of Germany*

of whom he was at that time a subject. That your petitioner has resided within the United States upwards of five years, and one year in the State of Pennsylvania last past, immediately preceding this his application to become a Citizen of the United States.

That he has never borne any hereditary title or been of any of the orders of nobility in his own or any other country.

He therefore prays, that on his making the proof, and taking the oath prescribed by law, he may be admitted a Citizen of the United States of America.

And he will ever pray, &c.

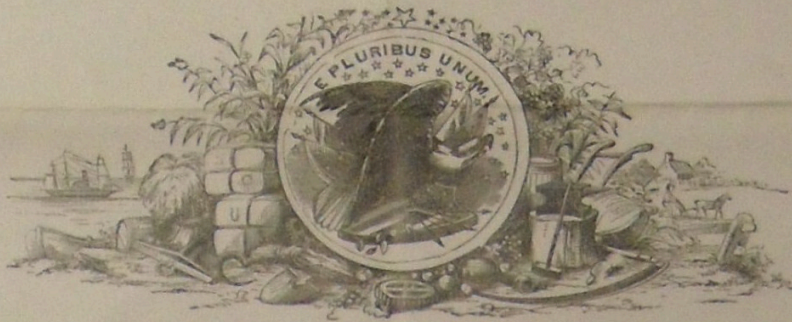

**Be it Remembered,** That before the Prothonotary of the Courts of Common Pleas for the County of Philadelphia, on the *12<sup>th</sup>* day of *November* in the year of our Lord one thousand eight hundred and eighty-seven, personally appeared *Louis Bicke* who upon his solemn oath did depose and say, that he is a Native of *Germany* now residing in the City of Philadelphia, aged *24* years, or thereabouts, and that it is BONA FIDE his intention to become a Citizen of the United States, and to renounce forever all allegiance and fidelity to any Foreign Prince, Potentate, State or Sovereignty whatever, and particularly to the Queen of Great Britain and Ireland, of whom he is now a subject.

**In Witness Whereof,** I have hereunto set my hand and affixed the seal of said Courts, this *12<sup>th</sup>* day of *November* in the year one thousand eight hundred and eighty-seven. (1887.)
